Federal Constitutional Court, order of 29 July 2022, 2 BvR 54/22 · Constitutional complaint against a court order for identification measures in accordance with section 81b Code of Criminal Procedure (since 1 October 2022: section 81b (1) Code of Criminal Procedure); considering the meaning and scope of the right to informational self-determination; lack of appropriateness and failure to discuss the specific necessity of individual parts of the measure (legal remedy successful). https://www.bundesverfassungsgericht.de

Bremen Administrative Court, judgement of 22 June 2022, 4 K 1/21 · Administrative decision on access under Article 15 GDPR by administrative act; no information pursuant to Article 15 (1) (e) GDPR if the applicant has proven knowledge of the relevant rights. | beck-online, no free access

Bavarian Supreme Court, order of 2 June 2022, 102 VA 7/22 • Access to a social care file; application of the "Doppeltürmodell" (meaning both request and transmission of data require a proportionate justification, cf. e.g. Federal Constitutional Court, order of 27 May 2020, 1 BvR 1873/13 and 1 BvR 2618/13) in relation to section 95 (1) Code of Criminal Procedure as well as with regard to a data transmission upon request of a professional supervisory authority for physicians (in continuation of Bavarian Supreme Court, order of 27 January 2021, 1 VA 37/20 and order of 6 August 2020, 1 VA 33/20). https://www.gesetze-bayern.de
