Court of Justice of the European Union, judgement of 4 May 2023, C-300/21 • A claim for damages under Art. 82 GDPR requires a – material or non-material – damage caused by an infringement of the GDPR; a (here: non-material) damage does not have to reach a certain degree of seriousness, though has to be verifiable; determination of the amount of damages payable under national law has to comply with the principles of equivalence and effectiveness. | https://curia.europa.eu
